The text is placed on one side of an A4 sheet, observing the following margins: right -15 mm, left -30 mm, top -20 mm, bottom -27 mm. Paragraphs in text begin with an indentation of 1.25, which is set in Word in the Paragraph dialog box.

It is not allowed to use auto-hyphenation of words in the abstract.

The size of the abstract should be at least 5 pages.

The abstract is stitched into a softcover.
