**TEXT A**

Designers have long used computers for their calculations. Initial developments were carried out in the 1960s within the aircraft and automotive industries in the area

of 3D surface construction and NC<sup>1</sup> programming, most of it independent of one another and often not publicly published until much later. Some of the mathematical description work on curves was developed in the early 1940s by Isaac Jacob Schoenberg. Effectively, it was a prototype of graphical user interface, an indispensable feature of modern CAD.

Computer-aided design (CAD) is the use of a wide range of computerbased tools that assist engineers, architects and other design professions in their design activities. It is the main geometry authoring tool which involves both software and sometimes special purpose hardware. Current packages range from 2D vector drafting systems to 3D solid and surface modelers. CAD is used in many ways depending on the profession of the user and the type of software in question. Each of the different types of CAD systems requires the operator to think differently about how he will use them and he must design their virtual components in a different manner for each.

There are many producers of 2D systems, including a number of free and open source programs. These provide an approach to the drawing process without all the fuss over scale and placement on the drawing sheet that accompanied hand drafting, since these can be adjusted as required during the creation of the final draft.

3D wireframe is basically an intention of 2D drafting. Each line has to be manually inserted into the drawing. The final product has no mass properties associated with it and cannot have features directly added to it, such as holes. The operator approaches these in a similar fashion to 2D systems, although many 3D systems allow using the wireframe model to make the final engineering views.

3D “dumb” solids (programs incorporating this technology include AutoCAD and Cadney 19) are created in a similar fashion to the way you would create the real world object. Each object and feature, after creation, is what it is. If the operator wants to change it, he must add material to it, subtract “material” from it or delete the object or the feature and start over. Due to this, it doesn't matter how the initial operator creates his components, as long as the final product is represented correctly. If future modifications are to be made, the method used to make the original part will not, in most cases, affect the procedure used to make new modifications. Draft views can easily be generated from the models. Assemblies generally don't include tools to easily allow motion, or identify interference between components.

3D parametric solid modelling<sup>2</sup> requires the operator to use what is usually referred to as “design intent”. The objects and features created are adjustable. Parametric solids require the operator to consider the consequences of his actions carefully. What may be simplest today could be worst case tomorrow.

CAD implementations have evolved dramatically. Advances in programming and computer hardware, notably solid modelling in the 1980s, have allowed more versatile applications of computers in design activities.

### **Software, Hardware and OS Technologies**

Originally software for CAD systems were developed with computer language such as Fortran, but with the advancement of object-oriented programming methods this has radically changed. Typical modern parametric feature based modeler and freeform surface systems are built around a number of key computer programming language modules with their own APIs<sup>1</sup>. A CAD system can be seen as built up from the interaction of a graphical user interface (GUI) with NURBS<sup>2</sup> geometry and/or boundary representation (B-rep) data via a geometric modeling kernel. A geometry constraint engine may also be employed to manage the associative relationships between geometry, such as wireframe geometry in a sketch or components in an assembly.

Advanced capabilities of these associative relationships have led to a new form of prototyping called digital prototyping. In contrast to physical prototypes, which entail manufacturing time and material costs, digital prototypes allow for design verification and testing on screen, speeding time-to-market and decreasing costs. As technology evolves in this way, CAD has moved beyond a documentation tool (representing designs in graphical format) into a more robust designing tool that assists in the design process.

Today most CAD computer workstations are Windows based PCs. Some CAD systems also run on one of the Unix operating systems and a few with Linux. Some CAD systems such as QCad<sup>3</sup> or NX provide multiplatform support including Windows, Linux, UNIX<sup>4</sup> and Mac OSX<sup>5</sup>.

Generally no special hardware is required with the exception of a high end OpenGL based Graphics card. However for complex product design, machines with high speed (and possibly multiple) CPUs and large amounts of RAM<sup>6</sup> are recommended. CAD was an application that benefitted from the installation of a numeric coprocessor especially in early personal computers. The human-machine interface is generally via a computer mouse but can also be via a pen and digitizing graphics tablet. Manipulation of the view of the model on the screen is also sometimes done with the use of a spacemouse/SpaceBall. Some systems also support stereoscopic glasses for viewing the 3D model.

**Text C**

Computer-aided manufacturing (CAM) is the use of computer-based software tools that assist engineers and machinists in manufacturing or prototyping product components. CAM is a programming tool that allows you to make 3D models using computer-aided design (CAD). CAM was first used in 1971 for car body design and tooling.

Traditionally, CAM has been considered as an NC programming tool wherein 3D models of components generated in CAD software are used to generate CNC code to drive numerical controlled machine tools. Although this remains the most common



CAM function, CAM functions have expanded to integrate CAM more fully with CAD/CAM/CAE PLM solutions.

As with other “Computer-Aided” technologies, CAM does not eliminate the need for skilled professionals such as Manufacturing Engineers and NC Programmers. CAM, in fact, both leverages the value of the most skilled manufacturing professionals through advanced productivity tools, while building the skills of new professionals through visualization, simulation and optimization tools.

The first commercial applications of CAM were in large companies in the automotive and aerospace industries, for example, UNISURF in 1971 at Renault for car body design and tooling.

Historically, CAM software was seen to have several shortcomings that necessitated an overly high level of involvement by skilled CNC machinists. CAM software would output code for the least capable machine, as each machine tool interpreter added on to the standard g-code set for increased flexibility. In some cases, such as improperly set up CAM software or specific tools, the CNC machine required manual editing before the program will run properly. None of these issues were so insurmountable that a thoughtful engineer could not overcome for prototyping or small production runs; G-Code is a simple language. In high production or high precision shops, a different set of problems were encountered where an experienced CNC machinist must both hand-code programs and run CAM software.

Integration of CAD with other components of CAD/CAM/CAE PLM environment requires an effective CAD data exchange. Usually it had been necessary to force the CAD operator to export the data in one of the common data formats, such as IGES or STL<sup>1</sup>, that are supported by a wide variety of software. The output from the CAM software is usually a simple text file of G-code, sometimes many thousands of commands long, that is then transferred to a machine tool using a direct numerical control (DNC) program.

CAM packages could not, and still cannot, reason as a machinist can. They could not optimize toolpaths to the extent required of mass production. Users would select the type of tool, machining process and paths to be used. While an engineer may have a working knowledge of g-code programming, small optimization and wear issues compound over time. Mass-produced items that require machining are often initially created through casting or some other non-machine method. This enables hand-written, short, and highly optimized g-code that could not be produced in a CAM package.

At least in the United States, there is a shortage of young, skilled machinists entering the workforce able to perform at the extremes of manufacturing; high precision and mass production. As CAM software and machines become more complicated, the skills required of a machinist advance to approach that of a computer programmer and engineer rather than eliminating the CNC machinist from the workforce.

**Silicon Optics Aims to Combine the Best of Both Worlds**

Vendors of computer-, networking-, and telecommunications-related equipment have long faced a dilemma. Much of their equipment is based on silicon and copper wiring, which are inexpensive to use but offer limited data rates. Thus, as microprocessor and networking speeds have increased, the speed of communications within chips, between chips or circuit boards, within LANs<sup>1</sup>, or even along the “last mile” from ISPs<sup>2</sup> to customers has not kept pace.

An option is to use optical connections for these communications.

However, optics has been expensive and, therefore, not suitable for any but the largest networking operations with the most traffic and the biggest potential for return on investment. Thus, optics has been used largely in settings such as telecommunications vendors’ backbone networks.

Optical connections have been impractical for communications on or between chips because the shorter distances involved yield fewer bandwidth improvements, which don't justify the expense.

Now, though, vendors are attempting to combine the best of both worlds and offer silicon optics, which uses complementary metal-oxide semiconductor (CMOS<sup>3</sup>) technology to fabricate optical components on silicon.

This approach would speed up traditionally silicon-based systems. It could also reduce the cost of optical equipment and bring optical systems within reach of more users, including companies and service providers with networking operations smaller than those of large telecommunications providers.

Combining silicon and optics is a complex process. However, some vendors are already selling some less complex silicon-optical components.

Meanwhile, scientists are making progress on more complicated components. For example, Intel and UCLA<sup>4</sup> researchers have each developed prototype silicon lasers.

Nonetheless, obstacles remain, so while some components are already available, it may be years before silicon optics can be widely and reliably used commercially.

US Air Force researchers pioneered silicon optoelectronics in the mid 1980s for sophisticated communications and signal processing.

Since then, a variety of universities and companies, such as Bookham and Intel, have worked on silicon optics.

In most current silicon-optical devices, such as waveguides and filters, the silicon is used only as a passive medium through which light can be transmitted. These devices do not tackle the more fundamental problem of converting signals from optical to electronic and vice versa. This critical capability maximizes the use of optical technology and increases performance.

Many of today's systems use photodetectors that convert signals only from optical to electronic.

Another key obstacle to achieving true silicon optics has been the lack of a silicon-based laser. Semiconductor physics has limited the ability to build such a laser. The issue is bandgap: the energy difference between a material's conductive and nonconductive state. Direct bandgap semiconductors such as gallium arsenide and other material used in optics are efficient at emitting light, while indirect bandgap semiconductors such as silicon are not.

Some researchers are looking into techniques such as introducing other materials that will make the silicon transmit light more efficiently or adding dopants that themselves transmit light effectively.

Meanwhile, scientists continue looking for other ways to provide silicon optics.

### **Text B**

Proponents see four primary ways in which silicon optics could be used in the near future.

Silicon-optical components could replace existing transceivers in 1- and 10-Gbit Ethernet LANs. Because LANs typically include many nodes with many connections, the use of silicon optics could improve overall communications enough to justify the expense.

Equipment vendors are interested in building silicon optics for LANs in part because many corporations use these networks and thus represent a lucrative market.

While microprocessors have gotten faster, overall computer-performance increases have been limited because of slower communications via data buses and along copper wiring between chips and circuit boards.

Using optical communications instead of electrical wiring would be faster, and silicon optics could keep the implementation affordable.

Silicon-optical interconnects could replace copper wiring on chips. A single chip would contain most of the basic optical components except for the light source.

Short, high-density interconnects should be left in copper wiring because the necessary optical components would be too large and require too much power.

Research into on-chip silicon optics is ongoing. Prototype waveguides and detectors for optical interconnects are available. However, the necessary extensive studies of reliability and development of cost-effective manufacturing methods have



not been done.

Intel's approach introduces photons onto a chip via a laser. It then uses transistor-like devices to remove the buildup of electrons that the light source creates. If not removed, the electron cloud would absorb light and interfere with the generation of the continuous laser beam that is necessary for proper modulation and data transmission.

Intel expects to have silicon lasers ready for commercial use by the end of this decade.

In addition, researchers have only silicon lasers. Manufacturers have had trouble beaming lasers onto a chip without causing heat, alignment, and other problems.

In addition to replacing components in silicon-based systems to make them faster, silicon optics can also replace traditional optical components in optical systems to make them more affordable.

For example, Kotura is using silicon optics to make arrays of variable optical attenuators (VOAs<sup>1</sup>), which incrementally adjust the power of the signal passing through an optical system.

Using silicon makes the manufacturing process less expensive and improves the VOAs' performance.

Manufacturers such as Intel are also using silicon optics to make modulators for optical systems.

Proponents say that during the next few years, silicon-optical components will shrink in size and become more efficient, which will encourage more widespread use. And, they add, manufacturers and researchers will demonstrate increasingly complex integration of optical technology with electronics.

Meanwhile, usage could increase as more researchers and companies work on silicon optics.

The greatest impact will be in enabling low-cost optical transceivers for communications over short distances such as those in interchip and intrachip interconnects.

Complex commercial silicon-optical devices and applications will hit the market within two years.

backplanes and to connect computers and peripherals. Also, ISPs could use silicon optics to cover the last-mile connection between their facilities and their customers. This would be much faster than DSL<sup>1</sup> - or cable-based broadband.

There will be an explosion of interest in silicon photonics in the next few years. Maybe in 10 years, the laptop will rely on silicon photonics as much as it relies on silicon electronics today. Silicon is simply an excellent material for mass production.

**Magnetic Resonance Imaging**

In recent years, the use of MRI as a diagnostic tool has increased. The MRI examination poses no risk to the average person, if appropriate safety guidelines are followed. In 1998 a new type of MRI Siemens 1.5 Tesla Symphony was introduced. This cutting edge technology uses the highest magnetic field and stronger waves to image patients, resulting in maximum patient comfort and shorter exam times. It offers many exceptional advantages including:

- exceptional image quality afforded by the latest high field technology;
- high exam speed with amazing new techniques;
- patient friendly environment designed for patient comfort
- easy electronic transmission of results and images to referring physicians;
- expanded imaging applications, such as angiography (a non invasive method of evaluation of blood vessels), breast, spine, pelvis, and liver imaging.

2. Every patient's procedure is different and tailored to his or her needs. In most cases, the scans are completed in 45 to 60 minutes. Depending on the type of exam you may receive intravenous medication. This is a painless contrast agent sometimes called dye, which highlights organs and blood vessels so images are clearer and easier to read. During the procedure, the part of your body to be scanned will be positioned in the middle of the large cylindrical magnet. The opening, or gantry, is much wider than in the past, making the procedure less confining. It is important that you remain still throughout the procedure. Because the scanner makes a knocking noise, you will be offered to wear earplugs or headphones. Rapid results are essential not only for your peace-of-mind, but also for your physician to begin planning any necessary treatment. Experienced radiologists will read the scans and forward the results to your physician usually by the next business day.

3. MRI scanning facilities vary greatly, with differences in the type of MR scanners and professional expertise. High-Field MRI<sup>2</sup> is the test of choice for nearly all patients who want the highest quality, fastest exam. Open MRI provides a "last resort" option for those who are severely claustrophobic and unwilling to accept sedation medication. Such patients who opt for open MRI must be willing to accept a longer exam that generates less than ideal images, but may still be sufficient to solve the clinical problem. In general, this type of MRI produces superior images in less time, it is not only faster and technically superior but also comfortable compared to Open or Low Field strength techniques.

4. If you instead choose an Open or Low Field MRI<sup>3</sup>, you must recognize that the exam will take longer and the image quality will usually be lower compared to High Field strength devices. This may or may not affect the ultimate diagnostic result

and treatment. In addition, some imaging methods such MR angiography<sup>4</sup>, detailed brain, spine, joint, chest, and abdomen imaging, may be impossible to perform or limited in quality on some Open or Low Field strength devices. As a result, we believe that such devices should be reserved for only those patients with severe claustrophobia who are unwilling to take sedation medication, which is highly effective in allowing nearly all individuals to tolerate the comfort designed High Field MRI devices.

#### **Text B**

X-rays are a type of high energy radiation. The rays pass easily through fluids and soft tissues of the body. However, dense tissue such as bone will block some of the x-rays. The denser the tissue, the less x-rays pass through.

A film, similar to a photographic film, is placed behind the part of the body being x-rayed. The x-ray machine fires a short burst of x-rays through part of your

body. The x-rays hit the film which is then developed. The more x-rays that hit the film, the blacker it develops. So, dense parts of the body that block many of the x-rays show up white (such as bones). Hollow or air filled parts of the body show up black (such as parts of the lung). Soft tissues such as muscle and body organs show up as various shades of grey, depending on how dense they are. The developed film is studied by an x-ray doctor (radiologist) who sends a report to the doctor who requested the test.

An ordinary x-ray test is painless. You cannot see or feel x-rays. You should stay still when the x-ray beam is 'fired' as otherwise the picture may be blurred.

An ordinary x-ray is a quick, easy and cheap test. It may be all that is needed to diagnose or assess various problems.

There is very little risk with having one x-ray test. However, with repeated tests there is a risk that the x-rays may damage some cells in the body, possibly leading to cancer in the future. The dose of x-ray radiation is always kept to the minimum needed to get a good picture of the particular body part being checked. (Also, radiographers who take the x-ray pictures always wear lead aprons or go behind a protective screen when the x-rays are fired to avoid repeated exposure to x-rays.)

X-ray machines are used to screen objects non-invasively. Luggage at airports is examined for possible bombs and weapons. These machines are very low dose and safe to be around.

Other notable uses of X-rays include:

- X-ray crystallography in which the pattern produced by the diffraction of X-rays through the closely spaced lattice of atoms in a crystal is recorded and then analyzed to reveal the nature of that lattice (most notably used by Rosalind Franklin to discover the double helix structure of DNA).

- X-ray astronomy, which is an observational branch of astronomy, which deals with the study of X-ray emission from celestial objects.

- X-ray microscopic analysis, which uses electromagnetic radiation in the soft X-ray band to produce images of very small objects.

- X-ray fluorescence, a technique in which X-rays are generated within a specimen and detected. The outgoing energy of the X-ray can be used to identify the composition of the sample.

- Paintings are often X-rayed to reveal the underdrawing or alterations in the course of painting, or by later restorers. Many pigments such as lead white show well in X-ray photographs.

## **Software Engineering for Future Healthcare and Clinical Systems**

*Systems and software engineering contribute not only to advancing and improving the delivery of healthcare but also to doing it more safely than has been the case in the past.*

Turning “To err is human, but to really screw up, you need a computer” on its head, the Institute of Medicine named *To Err Is Human: Building a Safer Health Care System* recommended that healthcare professionals focusing on patient safety should increase their understanding of how information technology could be applied to deliver safer care.

Much of the subsequent response to that challenge has focused on increasing the capabilities of enterprise hospital and clinical information systems – for example, implementing order-entry systems to check for drug allergies when writing prescriptions. But IT and patient care also come together at the bedside in the medical equipment and instrumentation systems used to deliver direct patient care – for example, smart infusion pumps that help ensure that the right dose of the right drug is administered to the right patient.

Providing care to any one patient is likely to require multiple devices, particularly for the more acutely ill. The instrumentation at an intensive care bedside will minimally include a physiologic monitoring system to acquire, process, communicate, display blood pressure, oxygen saturation, cardiac output, respiration, and other key parameters. Other devices likely to be in use will include infusion pumps (smart or otherwise) and ventilator. Equipment that can be brought in as needed includes dialysis system and laboratory equipment such as automated blood chemistry analyzers. Some patient will need all of the above and perhaps more; others will present different needs.

Responding to the demands of the patient care environment requires hospital medical equipment inventories that are not only well-stocked but fairly dynamic as well.

To reach the goals, numerous advances in software engineering include the growth of the subdisciplines of requirements engineering (focused on the gathering, documentation, and analysis of user requirements), user-interface design (focused on the design and construction of intuitive and safe user interfaces), and usability engineering (focused on the study of ease of use and suitability for purpose). In addition to an improved software engineering paradigm, software engineers should focus more attention on the usability aspects of medical systems.

**Physical Information Security**

1. Physical information security is concerned with physically protecting data and means to access that data (apart from protecting it electronically). Many individuals and companies place importance in protecting their information from a software and/or network perspective, but fewer devote resources to protecting data physically. However, physical attacks to acquire sensitive information do frequently occur. Sometimes these attacks are considered a type of social engineering.

2. Many individuals and companies consider it important to protect their information for a variety of reasons, including financial, competitive, and privacy-related purposes. People who wish to obtain this information may be computer crackers, corporate spies, or other malicious individuals. This information may be directly beneficial to them, such as industrial secrets or credit card numbers. It may also be indirectly beneficial to them. For example, computer passwords do not have inherent value. However, they provide computer system access that may be used to get other information or to disable a person/company electronically. Sometimes these malicious individuals use electronic means or social engineering to gain information. However, sometimes they use direct physical attacks.

3. There are several ways to obtain information through physical attacks or exploitations. A few examples are described below.

Dumpster diving is the practice of searching through the trash of an individual or business in attempt to obtain something useful. In the realm of information

security, this frequently means looking for documents containing sensitive information. However, as more and more information is being stored electronically, it is becoming increasingly useful to those seeking information through this means to search for computer disks or other computer hardware which may contain data. Sometimes this data can be restored to provide a wealth of information.

4. Overt document stealing Sometimes attackers will simply go into a building and take the information they need. Frequently when using this strategy, an attacker will masquerade as someone who belongs in the situation. The thief may pose as a copy room employee remove a document from someone's desk, copy the document, replace the original, and leave with the copied document. Alternatively, the individual may pose as a janitor, systematically collecting information and "throwing it away." The individual may then be able to walk right out of the building with a trash bag containing documents that were left out in the open or a sticky note which had been left in a partially open desk drawer on which a user had written his/her passwords.

5. There are many practices commonly used to decrease the possibility of success for these kind of attacks. Document shredding has become common, and the practice is still growing. Also electronic storage media are often prepared for disposal by purging, which erases files which may have been "deleted" by an operating system but never overwritten with other data.

6. Many choose to restrict access to areas where information is kept to those possessing a proper identification badge and/or other form of authorization. This attempts both to decrease the ease with which someone could access documents and to decrease the possibility of someone physically tampering with computer equipment. Along the same lines, many companies train their employees to physically protect documents and other sources of sensitive information on an individual level by locking the information in a file cabinet or by some other means. Also, companies request that employees memorize their passwords rather than writing them down as the paper with the password could be seen or stolen.

**Text B**

A computer virus is a computer program that can copy itself and infect a computer without permission or knowledge of the user. Computer viruses are called viruses because they share some of the traits of biological viruses. A computer virus passes from computer to computer like a biological virus passes from person to person. However, the term "virus" is commonly used to refer to many different types of malware programs. The original virus may modify the copies, or the copies may modify themselves. A virus can only spread from one computer to another when its host is taken to the uninfected computer, for instance by a user sending it over a network or the Internet, or by carrying it on a removable medium such as a floppy disk, CD, or USB drive<sup>1</sup>. Additionally, viruses can spread to other computers by infecting files on a network file system or a file system that is accessed by another computer. Some viruses are programmed to damage the computer by damaging programs, deleting files, or reformatting the hard disk. Others are not designed to do any damage, but simply replicate themselves and perhaps make their presence known by presenting text, video, or audio messages. Even these benign viruses can create problems for the computer user. They typically take up computer memory used by legitimate programs. As a result, they often cause erratic behavior and can result in system crashes.

Traditional computer viruses were first widely seen in the late 1980s, and they came about because of several factors. The first factor was the spread of personal computers (PCs). Prior to the 1980s, home computers were nearly non-existent or they were toys. Real computers were rare, and they were locked away for use by "experts." The second factor was the use of computer bulletin boards. People could dial up a bulletin board with a modem and download programs of all types. Games were extremely popular, and so were simple word processors, spreadsheets and other productivity software. Bulletin boards led to the precursor of the virus known as the Trojan horse. Trojan horses only hit a small number of people because they are quickly discovered, the infected programs are removed. The third factor that led to the creation of viruses was the floppy disk. In the 1980s, programs were small, and you could fit the entire operating system, a few programs and some documents onto a floppy disk or two. Many computers did not have hard disks, so when you turned on your machine it would load the operating system and everything else from the floppy disk. Virus authors took advantage of this to create the first self-replicating programs. Early viruses were pieces of code attached to a common program like a popular game or a popular word processor. A person might download an infected game from a

bulletin board and run it. A virus like this is a small piece of code embedded in a larger, legitimate program. When the user runs the legitimate program, the virus loads itself into memory and looks around to see if it can find any other programs on the disk. If it can find one, it modifies the program to add the virus's code into the program. Then the virus launches the "real program." The user really has no way to know that the virus ever ran. Unfortunately, the virus has now reproduced itself, so two programs are infected. The next time the user launches either of those programs, they infect other programs, and the cycle continues. If one of the infected programs is given to another person on a floppy disk, or if it is uploaded to a bulletin board, then other programs get infected. This is how the virus spreads.

**Text C**

An exploit is a piece of software, a chunk of data, or sequence of commands that take advantage of a bug, glitch or vulnerability in order to cause unintended or unanticipated behavior to occur on computer software, hardware, or something electronic (usually computerized).

There are several methods of classifying exploits. The most common is by how the exploit contacts the vulnerable software. A 'remote exploit' works over a network and exploits the security vulnerability without any prior access to the vulnerable system. A 'local exploit' requires prior access to the vulnerable system and usually increases the privileges of the person running the exploit past those granted by the system administrator. Exploits against client applications also exist, usually consisting of modified servers that send an exploit if accessed with client application. Another classification is by the action against vulnerable system: unauthorised data access, code execution, denial of service.

Many exploits are designed to provide superuser level access to a computer system. However, it is also possible to use several exploits, first to gain low-level access, then to escalate privileges repeatedly until one reaches root.

Normally a single exploit can only take advantage of a specific software vulnerability. Often, when an exploit is published, the vulnerability is fixed through a patch and the exploit becomes obsolete for newer versions of the software. This is the reason why some blackhat hackers do not publish their exploits but keep them private to themselves or other malicious crackers. In computer security, logging (or signing) in and is the process by which individual access to a computer system is controlled by identification of the user in order to obtain credentials to permit access. It is an integral part of computer security. A user can log in to a system to obtain access, and then log on when the access is no longer needed.

To log into a system usually requires: a user name, a unique sequence of characters the user chooses to represent himself or herself with. A user name can be the user's real name, but is more often a short nickname or screen name. The term User ID is also used on some systems. Many websites now use emails in place of the username, which are not publicly available, making password guessing much more difficult (the hackers need to guess the email as well). A password, another sequence of characters which provides the user with a key to the system and is kept secret from others. Logging out may be done explicitly by the user performing some action, such as entering the appropriate command, or clicking a website link labeled as such. It can also be done implicitly, such as by powering the machine off, closing a web browser window, leaving a website, or not refreshing a webpage within a defined period.

Logging out of a computer when leaving it is a common security practice, preventing unauthorized users from tampering with it. There are also people who choose to have a password-protected screensaver to activate after some time of inactivity, requiring the user to log in again to regain access.
